Dear Ms. Evans:

This is a request under the Maryland Public Information Act (MPIA), State Government Article §§ 10-611 to 628. I am making this request as a resident of Rockville. In this capacity, I wish to inspect all records in your custody and control pertaining to the following:

- (A) All emails and correspondence, related in any fashion generated, that contain the name "Jordan" in the body of the text. In the case of emails, it should include all emails sent to and/or from any City of Rockville email address and to and/or from any non-City email address. City of Rockville email format is defined as "*.rockvillemd.gov", where "*" is any username in the rockvillemd.gov domain. Usernames should include all individuals (City staff, senior directors, city manager, elected officials, etc) and groups (such as mayorcouncil, pio, etc), for the period covering September 10th, 2010 up to and including the present. There is an older email domain, but I believe it has not been used in the recent past.
- (B) All emails and correspondence, related in any fashion generated, that were sent from any City of Rockville email address to a Ms. Theresa Defino, and/or sent from Ms. Theresa Defino to any City of Rockville email address. City of Rockville email addresses should follow the same guidelines as described in (A) above. Email addresses for Ms. Defino should include, but not be limited to, tdefino@aol.com. The same time period as in (A) above should be covered, September 10th, 2010 up to and including the present.
- (C) All emails and correspondence, related in any fashion generated, that were sent from any City of Rockville email address to a Mr. Art Stigile, and/or sent from Mr. Art Stigile to any City of Rockville email address. City of Rockville email addresses should follow the same guidelines as described in (A) above. Email addresses for Mr. Stigile should include, but not be limited to, "artsti@comcast.net" and "artws@comcast.net". The same time period as in (A) above should be covered, September 10th, 2010 up to and including the present.

If all or any part of this request is denied, I request that I be provided with a written statement of the grounds for the denial. If you determine that some portions of the requested records are exempt from disclosure, please provide me with an explanation as to why, and the portions that can be disclosed.

I also anticipate that I may want copies of some or all of the records sought. Therefore, if you have adopted a fee schedule for obtaining copies of records and other rules or regulations implementing the Act, please send me a copy.

If you are not the custodian of these records, please let me know who is, and kindly forward my request to that individual.
